Responsibility for personal data collected on this site

The Swiss Ski and Snowboard School of Airolo is a company registered in the commercial register of the Canton of Ticino, with the number CHE-109.655366 IVA, the main office is located in CH-6780 Airolo, Switzerland.

Purpose of data use

You can visit our website without providing any personal information. Only non-personal usage data, such as the IP address, the last page visited, the browser software used, the date, time, etc., are collected anonymously in order to highlight trends and improve our online offer. This data is not used to draw conclusions about you.

This information is essential for:

- online booking of the various courses we offer;
- respond to your requests and requests made personally;
- process bookings made online, by e-mail or telephone;
- send you the booking confirmation and any updates;
- communicate with you in general;

Confidentiality of information

Your personal data is not resold or passed on to third parties outside our Ski School.

We may only share your information in the following circumstances:

- in response to a subpoena, court order or other legal process; in order to establish or exercise our legal rights; to defend ourselves against any legal claim; or in all other cases provided for by law. In these cases, we reserve the right to make or waive any legal objection or legal right available to us.
- If we deem it appropriate to investigate, prevent or take any necessary action against any illegal or suspicious activity; in order to protect and defend the rights, property or safety of our business, this website, our customers or third parties; and in accordance with our Terms of Service and other agreements.
- In connection with a commercial transaction, such as a sale, merger, merger or in the event of bankruptcy.

Except in the above cases, which are highly unlikely, your personal data will not be shared with third parties.
